

2021 OKLAHOMA LEGISLATIVE SCHOOL CHOICE REPORT CARD

OVERVIEW

This report card evaluates how state legislators voted on school choice issues during the 2021 legislative session by tracking their votes on 4 key pieces of legislation dealing with the expansion of access to educational options for Oklahoma families and kids.

In 2021, the Oklahoma State Legislature saw advocacy efforts from parents across Oklahoma like never before, a direct result from the educational disruption caused by 2020's coronavirus pandemic. During the 2020-2021 school year, which began virtually for most districts, Oklahoma parents began voicing their concerns to their local school districts and quickly realized that parent opinions about their own children's well-beings were not being considered or invited into the educational decision-making process. This then led parents to band together and call for legislative actions to increase school choice opportunities for Oklahoma families, and elevate parent roles in educational decisions made at the school, district and state level. Because of this, the 2021 report card includes a "Parents' Choice Honor Roll" list with state legislators who have supported parents throughout the 2021 legislative session by authoring/co-authoring beneficial school choice bills and fostering productive conversations with parent advocates.

ChoiceMatters is a statewide program that focuses on giving parents information, resources and support to help them navigate Oklahoma's pre-K through 12th grade education offerings, and Parent Voice Oklahoma is a grassroots coalition of parent volunteers that focuses on elevating parents' inherent right to have a voice in their student's education and organizing communities to take action on behalf of equitable and competitive educational opportunities for all Oklahoma student and families.

BILL SUMMARIES

HOUSE BILLS

HOUSE BILL 2078 🗸

Authored by Rep. Kyle Hilbert, Sen. Zack Taylor; Co-Authored by Rep. Terry O'Donnell, Rep. John Echols, Rep. Tammy West, Rep. Dean Davis, and Rep. Toni Hasenbeck.

HB 2078 relates to the current school funding formula and modifies some calculations of state aid distribution to districts. This measure will create a real-time, accurate funding formula reflecting the yearly average per pupil enrollment in a school district, rather than the previous formula that allowed for budgets to be made on a three-year high.

SB2078 supports parent power by creating a fiscally responsible valuation that reflects current and accurate student enrollment in a given district, ensuring that families have access to equitable educational options in any traditional public school district they choose.

Last Action: The bill was referred to the Senate Appropriations Committee (2/17/21) and saw amendments as well as a principal House author substitute from Rep. McCall to Rep. Hilbert (2/22/21). HB2078 was voted on by the House and passed with 68 Yes and 30 No votes. The bill was sent to the Senate and referred to the Education, Appropriations and Finance Committees before passing with 27 Yes and 19 No votes (3/31/21). The bill was sent to Governor Kevin Stitt and approved on 3/31/21.

HOUSE BILL 2701 🛛

Authored by Sen. Dave Rader; Co-Authored by Rep. Chris Kannady, Rep. Ryan Martinez, and Rep. Jon Echols.

HB2701 increases the total authorized credits for taxpayers making a contribution to an eligible scholarship-granting organization or to an eligible educational improvement grant organization. Current law caps the credits to \$3.5 million and \$1.5 million respectively. This measure proposes to increase the cap on tax credits to \$40 million for both types of contributions. The measure also broadens eligible schools to include schools located in any public-school district.

HB 2701 would have supported parent power by encouraging individuals to invest private donation dollars to private institutions, with a tax credit incentive to facilitate funding for school choice. The bill included language that would have raised the overall cap on this program and the available tax credit, thereby increasing overall donations to the program.

Last Action: The bill passed the Education Committee with 18 Yes and 12 No votes. The bill was then referred and withdrawn from the Rules Committee and then referred to the Appropriations Committee (2/22/21). The bill was not heard by the house committee deadline and the title was stricken on 2/25/21.

*Although HB2701 dd not make it past the House floor, a similar bill (SB1080) would be introduced later in the 2021 legislative session, passing both Senate and House floors and signing into law a recordbreaking new budget deal increasing the cap on tax credits for EIGOs and SGOs

SENATE BILLS

SENATE BILL 210 🛛

Authored by Sen. Brent Howard; Co-Authored by Sen. Garry Mize, Sen. Nathan Dahm, and Sen. Shane Jett.

SB210 relates to the provisions of removing school board members by recall petition. This measure increases school board accountability to the district's community by proposing the possibility of recalling board members by petitions signed by at least 51% of qualified voters within the board district and filed with the school district boar of education.

SB210 would have supported parent power by creating a process for district parents and community members to remove a school board member who is not meeting the responsibilities and expectations of the seat and increasing their accountability to the families they serve!

Last Action: The bill was referred to the Senate Education Committee (2/2/21) where it was kept on hold and eventually died 2/3/21.

SB126 relates to the modification of qualifying individuals who may be eligible to receive the Lindsey Nicole Henry Scholarship for Students with Disabilities Program, which currently is available to families of public school students with disabilities and/or an IEP and to families with a student who has been in out-of-home placement with the Department of Human Services. This measure would expand access to private school scholarships funded by this program to include active US military families and families who have undergone kinship placement of their student.

SB126 would have supported parent power by expanding access to the LNH scholarship, which allows families to have additional financial opportunities to choose the best educational option for their student!

Last Action: The bill was referred to the Senate Education Committee (2/2/21), then later amended and passed by the Senate floor with 35 Yes and 8 No votes (3/9/21). The bill was referred to the House Common Education Committee (3/22/21) and passed the committee with 74 Yes and 21 No votes (4/19/21) but was later rejected and called into the Conference Committee on Common Education (5/6/21) where it was held over and killed in committee on 5/27/21.

SENATE BILL 229 🗸

SB229 relates to school funding and the creation of the Redbud School Funding Act, which will modify distribution of funds raised from taxes on medical marijuana retail sales to the State Public Common School Building Equalization Fund. This measure will provide State Aid in the form of redbud school grants to Oklahoma public charter schools.

SB229 supports parent power by creating an equitable funding formula that benefits state school districts that fall below the state average in dedicated property taxes—such as public rural and charter schools!

Last Action: The bill was referred to the Education Committee (2/2/21), and amended, then passed out of committee with 37 Yes and 8 No votes. (3/11/21). The bill was referred to the House Common Education Committee (4/6/21) where it was amended and passed out of the Common Education Committee with 88 Yes and 0 No votes (4/21/21). House Amendments were rejected, and the bill was sent to the Conference Committee, and then sent to a Special Conference Committee on Common Education (5/19/21). The bill passed the Senate floor with 38 Yes and 8 No votes (5/20/21) and then later passed the House floor with 97 Yes and 1 No vote (5/24/21) before being approved by Governor Kevin Stitt on 5/28/21.

SENATE BILL 783 🗸

SB783 relates to modifying provisions of the Education Open Transfer that would enable families to transfer from one district to another at any time during the year up as long as the school site in question continues to have capacity in that grade level. This measure will allow a student to be granted a 1-year transfer, and the school district retains the ability to deny the continued transfer due to disciplinary and/or absence issues.

SB787 supports parent power by making it possible for families to undergo a transparent and true open transfer process that will allow for their students to transfer to the public school that best meets his or her needs!

Last Action: The bill was referred to the Education Committee (2/2/21) then amended and passed by the Senate floor with 32 Yes and 15 No votes (3/2/21). The bill was passed the House floor with 68 Yes and 19 No votes and approved by Governor Kevin Stitt on 3/31/21.

SENATE BILL 1080

SB1080 relates to income tax credits for contributions made to certain education improvement grants or scholarship-granting organizations. This measure proposes a budget plan to modify funding for the Equal Opportunity Scholarship Act.

SB1080 supports parent power by creating financial opportunities in the form of private school scholarships for low-income families to utilize and public school grants to use for innovative school programs—in other words, more quality choices for our students!

Last Action: The bill was referred to the Joint Appropriation and Budget Committee (5/3/21) and was amended and passed out of committee onto the Senate floor (5/17/21). The bill passed the Senate with 36 Yes and 11 No votes and referred for engrossment (5/18/21) before passing the House floor with 63 Yes and 36 No votes (5/20/21). Governor Stitt approved and signed SB1080 into law on 5/21/21.
